I do not believe I have been exposed to someone with a suspected and/or confirmed case of *Coronavirus/Covid-19.

*Refers to Coronavirus/Covid-19 and any of its variants which may include, but is not limited to: Delta, Omnicron, and variants yet to come.

I hereby release and agree to hold Trail's End Ranch harmless from, and waive on behalf of myself, my heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses, and compensation for damage or loss to myself and/or property that may be caused by any act, or failure to act of Trail's End Ranch, or that may otherwise arise in any way in connection with any services received from Trail's End Ranch.
